# The Serendipity Genealogist

For several years I had heard vague rumors that somewhere—in someone's attic, among someone's keep-sakes—a letter from my great-great grandfather Cummins had been preserved.

Someone was always going to remember to send me a copy. Finally, someone did—my second cousin Joyce Drummond.

The letter is a mixture of pathos and hilarity. Grandpa was writing to his wife from the gold fields in California. He told her first about the death of their son John. Grandpa told her that he did "everything a father could do," which included buying a casket for the son (something that was not customary in California, he informed her).

The recounting of the son's death is strangely matter-of-fact. However, later in the letter Grandpa tells Grandma that the joy of life has dimmed since the son is no longer there.

Grandpa provides a catalog of all the Missouri men in his camp and their ailments. He assures Sarah (his wife) that they have laid in \$300 worth of supplies for the winter.

At one point he tells her that he will come home if she wants him to—all she has to do is tell him so. He also tells her that he believes he can make some money if he stays there. A footnote added by a later descendant says that he did indeed stay—for three years—and that when he returned to Missouri, he had \$12,000—a pretty hefty sum in those days.

He gives her a running account (pun intended) of his own ailments and tells her exactly what various necessities cost him.

After telling his children he has heard a rumor that some of them are thinking of getting married, he orders them not to do so.

The serendipity in the letter shows up in another note appended to Grandpa's message. The unknown writer says that the Cummins came to Missouri from Lexington, Ky., where they had a tobacco plantation and many slaves, and that the Elliotts (Sarah's family) came from the same background and location.

I've been wandering around in Kentucky data for years trying to get a place to start—thanks to serendipity again, I know where to write and visit. I am not foolish enough to believe that all the family myths are true (I'm not even going to worry about the rumor that we are direct descendants of Daniel Boone), but it is nice to have a little guidance from the past.

# Early History of Arlington . . .

Arlington is located 18 miles southwest of Hutchinson on the Rock Island railroad. Established on the route of the "Sun City Trail" of early days, Arlington was a stopping place for haulers because of the plentiful water and grass. Later it was near the trail over which cattle were driven from Texas to Abilene.

The townsite was laid off in August 1877 by A.K. Barrel (or Burrell) and G.T. Empey. Impressed by the rapid, steady flow of the Ninnescah River, Empey and Burrell built a mill road and mill in 1877 naming the "meager community which crept in around it" Arlington after the famous Arlington Heights overlooking Washington, D.C. (History 73).

### The first building

The three-story frame mill was the first building in the town. It was 30 by 40 feet, with four buhrs and a daily capacity of 50 barrels. During the several years the mill operated, it was a convenience to people southwest of Hutchinson, providing the nearest flour supply.

The mill and its pond became popular with farmers and hunters; however, without a railroad, the town did not hold much promise.

### **Additional firsts**

The next building was Arlington House, a hotel built by P. Howell. The first post office was established Feb. 7, 1878. H.H. Purdy was the first postmaster. The first store was established by M.C. Rogers. The first school in 1878 was taught by Miss Juliet Courtright in a small, privately owned log building. In 1879, a frame building was constructed to be replaced later by a brick building.


# Creating a township

On Jan. 4, 1881, Robert Burling and 56 others presented a petition to create a new municipal township. The territory was to come from the east half of what was then Langdon Twp. The new township was Township 25, Range 8 West. The first officers were elected Feb. 5, 1881, but the results were misplaced so the names of the first officers were never filed.

#### Railroad comes

For almost a decade after its origin, the town was static. In April 1886, the news was spread that the Rock Island extension would cut across Reno County.

To express the community's interest in the railroad, a petition was circulated beseeching the railroad officials to include Arlington on their line.



The Arlington citizens decided to model their campaign after the successful effort Turon had launched earlier. The Arlington leaders formed a town company and offered 51 percent of the stock to the Rock Island.

Mr. Ewing, the Rock Island's right-of-way man, arrived and purchased a "swatch of land" that took the houses of Lom Cecil, W. Filey, Dick Cecil, J.E. Taylor, D.M. Eliot, Chas Cecil, and Mrs. Jane Filey, as well as the M.E. parsonage.

The railroad bought the lots and the people moved the houses.

### Commercial growth

Arlington became a bustling railroad town. The commercial establishments increased. Seven contractors were in business. Before the track arrived, hotels and restaurants were started, along with two drug stores, two millineries, a jewelry store, and a photographer. There was a brick yard which employed 15 men who produced 10,000 bricks a day. The Arlington nursery was founded.

Four additions were made to the original platted town. Arlington had dreams of becoming a great watering place—the mill pond was to become a lake where yachts would sail.

The promise began to dull though when a railroad bond controversy brought political turmoil. This was followed by a protracted drought.

# **History of Arlington, (continued)**

### **Early Settlers**

Alfred L. Sponsler came to Reno County in late 1886 from Aledo, Ill., where in the law firm of Pepper and Sponsler he practiced law after being admitted to the bar in May 1885. He located in Arlington, expecting to engage in practical law, but instead he became involved in real estate until November 1889 when he moved to Hutchinson.

It was during the time in Arlington he made one of the most remarkable political races in the history of the state, running as a Republican candidate for the nomination for state senator from his district. The Senatorial Convention, meeting in Pratt, was deadlocked from the first ballot. After three days, it adjourned to meet again at Turon where three more days were lost in ineffectual balloting, after which it adjourned. At the next call of the district committee, the convention, again at Turon, cast several hundred ballots without a nomination. Sponsler, who was several times within one vote of those needed for nomination, withdrew releasing his delegates, and the nomination went to F.E. Gillette.

In 1889. Alfred and his brother John L., founded the Hutchinson Times, in 1890 adding the Republican and later four other small papers, merging them with the Times until 1891 when they purchased the Hutchinson Daily News with which the Times was merged. They continued publishing until the fall of 1895 when they sold out to William Y. Morgan. Sponsler later joined Thomas Armour in establishing a printing and publishing house in Hutchinson.

Sponsler continued to be active in politics and served as secretary of the Kansas State Fair.

Alfred was born 30 Apr 1860 in Mercer County, III., the third son, fifth child of Lewis and Maria Wolfe Sponsler. He married Minnie Bentley 27 Sep 1887 (she was born 5 Sep 1862, Mercer Co., III., daughter of James L. and Nancy Smith Bentley). Alfred died 10 June 1915 at his home at the corner of 12th and Washington.

#### Layman

Preston Layman (b. 13 Sep 1833, Newport, Tenn.) left his southern home to serve with the Union Army-Company E, 2nd Tennessee Cavalry—serving until the end of the war. In February 1882, he settled in Arlington Twp., buying 110 acres from George Alexander and adding land until at the time of his death 27 Nov 1909 he owned 1,120 acres.

His wife was Harriet McNabb (b. 4 May 1843, dau. of John and Elizabeth Ruga McNabb). Their children were Roscoe C. (b. 21 Nov 1875), William C. Della, and Arthur, all born in Newport, Tenn.

Roscoe C. was married 3 May 1899 to Emma E. Fuller, daughter of Daniel E. and Amy Lynch Fuller of Arlington. He attended normal school at Emporia and taught two years before bcoming principal of the Langdon Twp. school for two years. He then farmed in Arlington Twp. until 1909 when he moved to Hutchinson.

Roscoe and Emma Layman had two children: Zora Mabel (b. in Langdon) and Velma Gwendolyn (b. in Hutchinson). The family home was at 307 12th Avenue, East.

#### Crabbs

Abraham B. Crabbs was another early Arlington resident, arriving with his parents in 1884. Born 9 Apr 1851 in Richland County, Ohio, Abraham was the son of Jacob M. and Catherine Bollman Crabbs.

Head of the firm of A.B. Crabbs & Company, real estate and loans, at Arlington, he was also one of the largest landowners in Reno County, a pioneer merchant at Arlington, and president of the first bank organized there.

Abraham's brothers were John L. and Albert E. One sister, Jennie, lived to adulthood. John L. was associated with A.B. Albert E. was a well-known Arlington merchant.

Abraham opened his store in August 1885 with about \$6,000 worth of merchandise. In 1887 he organized the town's first bank, the Arlington State Bank, selling out to the Citizens State Bank in 1889 although retaining his financial interest in the bank. In 1889 he and his brother John erected a grain elevator which they ran until \$904 when they sold out to Hoffman Grain Co., of Enterprise.

In 1902 Abraham became associated with J.S. Trembley in the hardware business in which he was connected until 1915. He owned about 4,000 acres, mostly in Reno County. As he aged, Abraham's eyesight failed. He never married.

#### Mastellar

D.H. Mastellar farmed in Langdon Twp and retired from farming to Arlington where he was engaged in the insurance business. He was born in Columbia Co., Pa., 29 Mar 1850, the son of Aaron and Elizabeth Dresker Mastellar.

Mastellar came to Kansas in 1874, locating first in Minneapolis, Kan. After that he went to Texas, spending four years there in government service. In 1885 he married Emma A. May and came to Reno County to "settle down." He bought one-half section of land in Langdon which he farmed until retiring to Arlington. The Mastellars had three children: Guy (who died in early youth), May, and Josephine.

#### **Barrett**

M.L. Barrett was the editor and publisher of the Arlington Enterprise. He was born in Conneaut, Ohio, 26 Feb 1866, the only child of J.M. and Catherine Barrett, early settlers of Arlington.

He was educated in the academy at Pierpoint, Ohio, after which he served an apprenticship to the tinner's tradefor three years. In Oct. 1893 he bought the Arlington Enterprise from J.E. Eaton.

Barrett married Jesse M. Hayes 10 Sep 1885. They had two children: Charles H. (who married Lilliam M. Gordley of Arlington) and Rose J., both associated with the publication and job printing business. The Barretts were members of the Presbyterian Church and Republicans.

#### Hinman

Milton E. Hinman, a rancher and miller at Sylvia, was born 21 Nov 1873 in Franklin Co., III. His father homesteaded in Huntsville Twp. Milton attended the Hinman district school then the Nickerson schools. He attended a course at Baker University at Baldwin, graduating from the normal department in 1898. He served as principal at Sylvia 1892-95, at Arlington 1896-97, at Plevna 1899-1902. He married Blanche Axtell (from Sterling) 2 Aug 1899. Their children were Helen (b. 1901), Lew (b. 1903), Dorothy (1908) and Dorr (b. 1913).

# **Process for getting information** on Homestead Land Patents

To obtain patent information on homestead land: first, contact the recorder of the county in which the land is located to get the legal description (township, range, section, and legal subdivisions); second, contact the Bureau of Land Management, giving the legal description. They supply copies of the patent for 50 cents per page-payment in advance.
