DELMA RUTH ASHCRAFT

SOUTH HUTCHINSON - Delma Ruth Ashcraft, 74, of 16 Truman Drive, died Aug. 13, 1998 at Hutchinson Hospital.

She was born Jan 3, 1924, at Anthony, the daughter of Cloy Hobart and Elizabeth May Mock Kincheloe. She graduated from Kingman High School in 1942.

A South Hutchinson resident for 38 years, moving from Kingman, she was a homemaker.

She belonged to First United Methodist Church, the Reno County Genealogical Society, Daughters of the American Revolution, had volunteered at the Hutchinson Public Library, Meals on Wheels, had been a Cub Scout den leader, a Brownies leader, a Girl Scouts leader and held various offices in the PTA.

On Jan. 29, 1943, she married Harrison M. "Harry" Ashcraft at Kingman. He survives.

Other survivors include: two sons, Morton Eugene, San Francisco and Robert W., Andover; a daughter, Lou Ann Elam, Lincoln, Neb.; a brother, Dean Kincheloe, Gladstone, Mo.; a sister, LaVeta Davis, Lexington, S. C.; eight grand-children; and three great-grandchildren.

She was preceded in death by her parents and two brothers, Duane and Ronald Kincheloe.

Graveside service will be at 2 p.m. Saturday in Walnut Hill Cemetery, Kingman, with Dr. D. Allen Polen Jr. presiding. Friends may call from 9 a.m. to 9 p.m. today and 9 a.m. to noon Saturday at Johnson & Sons Funeral Home, Hutchinson.

Memorials may be sent to the Reno County Genealogical Society or to the church, both in care of the funeral home.

Delma was a very active member of the Reno County Genealogical Society. For many years, she organized the RCGS volunteers to staff the Kansas Room at the Hutchinson Public Library. She was a member of many committees which included the compilation and publication of the Cemetery Records of Reno County, Early Marriage Records of Reno County 1872-1911, 1880 Census Reno County, Kansas. Recorded Early Births of Reno County, Kansas 1890-1911 + Index was compiled and published because of Delma's efforts. She was putting information from the marriage register on her computer at the time of her death. She was always ready to help with any workshops. Let me conclude by stating that the genealogical community has lost a wonderful lady who was a deligent researcher and volunteer.

Editor's note: I will miss seeing her at the Family History Center and at the RCGS meetings. I'm afraid that I have left out some of the committees that Delma took part in, for which I apologize.

SOUND GENEALOGICAL RESEARCH

Recommended by the National Genealogical Society

Remembering always that they are engaged in a quest for truth, family history researchers consistently:

- Record the Source for each item of information they collect.
- Test every hypothesis or theory against credible evidence and reject those that are not supported by evidence.
- * Seek original records or reproduced images of them as the basis for their research conclusions when there is reasonable assurance they have not been altered.
- Use compilations, communications, and published works, whether paper or electronic, primarily for their value as guides to locating the original records.
- * State something as a fact only when it is supported by convincing evidence and identify the evidence when communicating a fact to others.
- Limit with words like "probable" or "possible" any statement that is based on less than convincing evidence and state the reasons for concluding that it is probable or possible.
- Avoid misleading other researchers by either intentionally or carelessly distributing or publishing inaccurate information.
- State carefully and honestly the results of their own research and acknowledge all use of other researchers' work.
- * Recognize the scholarly nature of genealogical research by making their work available to others through publication, by placing copies in appropriate libraries or repositories, and by welcoming critical comment.
- Consider with open minds new evidence or the comments of others on their work and the conclusions they have reached.

WESTERN RENO COUNTY CHURCHES

Continued from the May issue.

TRIUMPH METHODIST CHURCH

The Triumph Methodist Church began as a group of rural folk meeting in the Triumph Schoolhouse. Earliest Sunday School records found were dated April 26, 1885. Meetings continued in the schoolhouse about 12 years.

In early March, 1897, the church was organized. Ezra Cundith donated an acre of ground for the building and was the chief carpenter. The building and furnishings cost about \$1500.

The cornerstone was laid May 27, 1897 and on October 24 of that year the church was dedicated. Rev. W. H. Gilliam and Rev. R. A. Dadisman were in charge of the service. Trustees of the church at this time were A. J. Gregg, I. C. Murphy, C. S. Lyons, H. R. Jones and A. L. McMurphy.

Sunday afternoon services were held with Rev. Dadisman as pastor from 1897 to 1899. Rev. Pollard became pastor in 1900 and D. D. Akin from 1904-1906.

In 1907 the Triumph Church was placed on the Alden charge and their pastor held afternoon services in the Triumph Church.

In 1898, an Epworth League was organized and by 1910 had a membership of 75, which included whole families as there was no evening preaching service.

The Quarterly Conference roll of March 1921 gives the following members: J. D. Wells, Orville McVay, Walter Halton, Will Wiltmer, Alvin Updegrove, Gus Lyons, Mr. W. Haltom, Mrs. W. H. Haltom, Mrs. Orville McVay, Claude Charter, Earl Seibert and Mrs. Logan Bennett.

In 1927, 28 or 29 men of the church farmed land furnished by E. C. Wellman and with the money from the corn, they added a basement and new entry to the church.

Triumph celebrated its 50th anniversary on October 26, 1947. Over 300 persons were present for the event. Rev. G. L. Coppedge gave the morning sermon and Rev. H. G. Grosdidier the evening service.

Although the Triumph Church was placed on the Alden Charge in 1907, the two churches, though cooperating, were separate entities until 1967 when the Triumph Church disbanded and most of their members transferred their membership to the Alden Church.

The church building was sold to Royce and Alice Matson to be used as their home.

RURAL CHURCH HISTORY

The Fairview United Methodist Church began as the Fairview United Brethren Church. The exact date of its origin in uncertain, but it is believed to have begun in the spring of 1880. Services were initially held in the Keddie schoolhouse located five miles north and one-half mile east of Sylvia. The first pastor was Rev. T. H. Watts, who served several years. Others who helped organize the church but their exact years of service are unknown were: Rev. Mont Barber, Rev. Zeigler, Rev. Rawlings, John Corley, and Rev. J. W. Foulk.

The first church building was built in the spring and summer of 1891 four and one-half miles north and one mile east of Sylvia, under the leadership of presiding elder, John Morrison, and Pastor Elwood Osbun. During the building of the church the following served as trustees: Thomas Keddie, Eli Mills, William Johnson, C. A. Smith, and Nelson Smith. The church was dedicated in the fall of 1891 by Bishop N. Castle. It was a one-room structure free of debt.

The Fairview Church was on a circuit with the Glendale Church, another country church south of Sylvia and with the Turon Church some twenty miles south of the Fairview Church. This was known as the "Turon Work".

The members of Fairview were dissatisfied with the service they were receiving from their pastors. Because the pastors were so far away and no paved roads then existed, the church was without services during the winter months due to roads being impassable. At the conference of 1905, the lay delegate, John Yust, a member of the Fairview Church, asked that Fairview be made a station and be given a full-time pastor. This was done and following the 1905 conference Rev. G. W. Morgan was appointed. The membership at this time was sixty-five persons. Rev. Morgan stayed as pastor until the fall of 1910.

In October of 1910 a group of twenty-four members requested their church letters and later organized the Pleasant Hill Church of the Nazarene. Other members followed in this drain upon membership and leadership of the church. Fairview was then placed with Glendale again and was known as the Sylvia circuit.

Preceding the organization of the Fairview Church, a German Methodist Episcopal Church was located six miles north and one-half mile east of Sylvia. They had a three-acre tract of land with a church house and a parsonage located on it. In 1911, because of the trend from the German language to the English language, this church was purchased by the Fairview Church. The United Brethren Church building was moved and attached to the west side of the Methodist building making it a two-room structure. The newly acquired and improved property was re-dedicated in 1911 by Rev. T. W. Pecks.

Between 1911 and 1925, there were many changes in the Fairview Church. Rev. H. McNish was appointed to the Sylvia circuit in the fall of 1912 and again in 1913. During his pastorate, a piano was purchased for \$400.00. In 1914, the circuit was left to be supplied by the annual conference. Rev. A. J. Covington was appointed to finish the year and was reappointed in 1915. Fairview was made a station again in 1915 with a membership of 126 persons. Again in 1916 Fairview was left to be supplied. Rev. C. E. Spore was secured and was reappointed in 1917. Rev. W. H. Hedden was appointed in the fall of 1918 and served until the fall of 1923.

In 1921, during Hedden's pastorate, the Congregational Church of Sylvia was purchased and a United Brethren class was organized. Many members living closer to Sylvia than to Fairview moved their membership to the town church. Membership at Fairview dropped from 126 to 70 during this move. Again in 1923, Fairview was left to be supplied. In the fall of 1924, Rev. Glen Megill was appointed. Rev. M. F. Longnecker was appointed in 1925, but left before his year was served.

On October 31, 1925, the Fairview parsonage was completely destroyed by fire and other housing had to be supplied for the ministers. The Rev. W. H. Hedden returned to the Fairview Church in the fall of 1927 and served one additional year. This made his pastorate the longest recorded up to that time. Rev. Hedden lived in Sylvia during this last appointment.

In the summer of 1928, the new parsonage was dedicated. Another building had been purchased and moved to the site where the old parsonage had burned.

The Rev. Clifford O. Nantz served the Fairview church in 1936 and 1937 and through his writings much of Fairview's history has been preserved. Rev. Nantz observed that the Fairview church appeared to have the characteristics of a cat - nine lives. It had outlived its sister churches, Turon and Glendale, and had supplied members for its neighboring Nazarene Church and also

to the Church in Sylvia.

In the twenty years between 1917 and 1937 the pastor's salary was as high as \$1440.00 and as low as \$500.00. The membership in 1937 was 66 and had a \$700.00 salary contract.

Rev. C. F. Hanold took over the work of the church in the fall of 1941 after the death of Rev. W. H. Hill. Rev. Hanold served twenty-five months. During his service the Fairview church was remodeled. The old log building that stood on the west side of the building was torn down. The steeple was removed and a basement was then dug under the one-room structure. The cost was \$3,600.00 and all costs had been paid when Rev. Hanold resigned to be pastor of the United Brethren Church in Stillwater, OK.

Conference Superintendent, Dr. Priddle, appointed Rev. W. F. Fooshee in the fall of 1943. He served the Fairview Church until May, 1952. During his service the basement was sealed, a furnace was purchased for \$500.00, the kitchen was enlarged and an electric range was purchased for \$200.00.

On November 16, 1946, the United Brethren and the Evangelical Churches merged and Fairview was known as the Fairview Evangelical United Brethren Church of Sylvia.

Between May of 1952 and June 1967 the Fairview Church was served by six different ministers. One of these, Rev. Frank Bushman, was a Mennonite missionary who had returned from his mission field. Another minister, Rev. Harold L. Peck, resigned to work with C.R.O.P.

Dale Chenoweth came to serve the Fairview Church and Sylvia EUB Churches in June of 1967. During his pastorate the Evangelical United Brethren and the Methodist Churches merged. On June 2, 1968, the Fairview EUB Church became the Fairview United Methodist of Sylvia.

Rev. Diane Helsel came to Fairview (then a three-point charge - Huntsville, Fairview and Sylvia) in June of 1973. It was during her pastorate that the members voted to close the Fairview church as of December 31, 1975. Rising costs and a small membership brought this about. The members of Fairview joined the Sylvia and Huntsville United Methodist Churches. This small country church closed its doors ninety-five years after its founding. The hand-carved pulpit was given to the Reno Co. Historical Museum. The church and its furnishings were sold at auction.

MISSOURI RESEARCH TIPS: When researching Missouri records during the period, early 1860's to about 1875 and you find a woman selling property, do not automatically assume she is a widow. It could be she was acting as the head of a family because of her husband's loss of civil rights because of his service in behalf of the South, or sympathy for the Southern cause. In such a case when his civil rights were restored later, you will find him handling financial transactions for the family again.

If you are searching for someone born in Missouri between 1805 and 1812, check Louisana records. During those years Missouri was a part of the Louisana Territory.

Prior to 26 June 1881, people in Missouri could get married and then record the marriage at any courthouse. If you are having trouble finding a marriage record, you may have to look in other counties, particularly the county where your ancestor finally settled. After this date, licenses were required before the marriage
