Volume 21 is ready to go to the publishers and indexing can now begin on Volume 22. The Master Index to Volumes 11 thru 20 of "The Forgotten Settler's" has been printed and distribution has started.

There have been 674 Territorial, 1863 Pioneer and 398 Early Settler certificates awarded since inception for a total of 2935 certificates.

HARRIET E. HOFFMAN AWARD

This is a special award, not necessarily given each year. The recipient must be connected to Kansas, having made outstanding contributions to Kansas historical and genealogical communities in the fields of:

1.) Enrichment to the genealogical and family history collections of Kansas; 2.) Publication of Kansas genealogical and family history; 3.) Promotion of genealogical education; 4.) Aiding in the improvement of library/research centers; 5.) Supporting genealogical efforts through work in local/state organizations and government.

Any member of KCGS may recommend a society or individual for this award. Recommendations should be given to the state president who with the officers shall select the awardee. Should an officer be recommended, the other officers should select this individual.

The award shall be in the form of a plaque given at the Annual Awards Banquet.

How would you like to see a copy of the actual land grant to your ancestor signed by the President at the time? If you have an ancestor who may have gotten a Land Grant in one of the Eastern States check out this site. http://www.glorecords.blm.gov

The Home Page will come up, read all the information. they ask you to put in your Postal Code for demographics only. then click on the "Search Land Patents". You will be asked to pick a state. A form will come up asking for any information you know regarding the land or patentee. Fill in what you know, even if it is only a surname. At the end of the form is the line "Genealogical Search Results". Click on this and wait for them to search for your entry. You can print out this listing. When you find one that you want to pursue further, click on Land Patent Search. When that page come up go to the green box in the lower right corner and put in the state and the accession # that was given you on the first search. This will bring up the land description and the location. At the end of this is more information on how you go about viewing the actual document. click on view document and the actual Land Grant will appear.

To view the land grant document your browser has to have a plugin to view a graphic in TIFF format. If you don't have one get the free download by clicking on the GET IMAGE VIEWER on the first page where you put in the postal code. Create a temp. directory and download the file to that directory. Go to your temp. directory and double click on the file. It will open and install itself, but it must be installed to a plugin folder in your browser. After installation the computer has to be rebooted. If you want to send away for a copy of the original there is a box marked to print out the form for requesting the document.

WHY LOOK AT THE CENSUS WHEN I ALREADY KNOW EVERYTHING ABOUT THESE FOLKS?

What will I get out of the census? I already know who was in my family and my mom knew all of the aunts and uncles. What I really want is to know more about how they got to California. Here are some folks I met in the census and some information about the family. This is just for fun but the facts are true - or at least that is what I found in the census of 1860 for Stanislaus County (CA).

WHICH WAY DID THEY GO?

Living in the Emory area was the Mitchell family—David a 48 year old farmer born in Tennessee and his wife, Cynthia,

39, also born in Tennessee. There are six children who appear to be the issue of David and Cynthia: Robert 17, Nancy A. 15, Hiram W. 12 and Eliza Jan 10 were all born in Missouri. Henry G. who is 3 was born in NY. Malinda age 1 was born in California. What does this tell us about how the

Mitchell family got to California? How do YOU think that the Mitchell family came to California? Yes, it is most likely that they went to New York and took a ship to come to California.

GENERAL HISTORY TIP

Prior to 1885 many thousands of couples from West Virginia, Ohio and other states eloped to Pennsylvania, eager to be wed in a state which did not require a marriage license. West Alexander, a small village just inside the western Pennsylvania line and halfway between Washington, Pa. and Wheeling, W. Va. on the old National road (Route #40), soon gained a far-flung reputation as a "Gretna Green". The local justices of the peace became famous as "Marrying Squires". They and the village ministers performed some 7,000 marriages during the years until Pennsylvania by act of assembly on Oct. 1, 1885, joined it's neighbors in requiring a license. It has long been a problem for historians and genealogists to find proof of Pennsylvania marriages because so few of these J. P. Books have survived.

NEW FAIR GROUNDS PLAN SHOWS ELABORATE SCHEME

Contemplate the Expenditure of \$150,000 Immediately--To Cost More Later On.

A. L. Sponsler, secretary of the Central Kansas Fair Association, has received a revised plat of the new fairgrounds. The new plan arranged ample walks from the entrance to the grand stand, through the center of the grounds. The walks pass a plaza, in the center of which is a band stand. On each side of the plaza is a restaurant. Farther on, directly in the central way, is the building to be used for horticultural and agricultural exhibits, and still father on is the grand stand and the race track.

At the left, just inside the main entrance, stands the secretary's office, and beyond is a lake. Farther on is a long "midway: where various amusements will be situated. A number of booths occupy space beyond the amusements, and still beyond, near the stables for track horses, is the horse exhibit building.

To the right from the main entrance stands the auditorium, and a park just beyond. The woman's building comes next, followed in quick succession by the dairy products, poultry, implements and livestock buildings. A space is left for outdoor exhibits, and sheep and swine pens occupy the extreme corner at the right of the race track.

The plans contemplate the immediate expenditure of approximately \$150,000 and further improvements to be added each year for many years to come.

DEATH OF BABY GIRL

The two-months-old daughter of Mr. and Mrs. A. J. Smith of 1109 East Fourth avenue, died this morning at 6:30 o'clock. Mr. Smith is employed at the Standard Oil company in East Hutchinson. The funeral Services will be held at the residence this afternoon at 4:30 o'clock. Burial will be in Eastside cemetery.

FUNERAL OF MRS. HARRISON

Will be held at Parents' Home Tomorrow Afternoon.

The funeral of Mrs. Eva Holloway Harrison, the young bride, who died yesterday morning, will be held at the home, 313 East First avenue at 4 o'clock tomorrow afternoon.

The Rev. H. E. Wolfe of the M. E. church, and the Rev. O. P. Harnish of the United Brethren church will conduct the funeral services. Burial will be at the East Side cemetery.

Mrs. Harrison was born February 13, 1886, at Wabash, Ind. She was the daughter of Dr. A. L. and Cynthia E. Holloway, 313 Eat First avenue. She moved with her parents to Hutchinson in 1896 and graduated from the high school in the class of 1906. She was married to John W. Harrison July 8, 9109. While on her wedding trip she was stricken with typhoid fever in Colorado. She was removed to her home and died at the end of two weeks.

Mrs. Harrison united with the Friends Church in childhood. She leaves her husband, father and mother and one sister to mourn her loss.

DRIVES TO PICNIC IN A BURNING BUGGY

J. B. Egbert, a farmer living near Langdon, has suffered the novel experience of having a buggy catch fire beneath him, while he was driving along the country road. When the blaze was discovered it had gained such headway Mr. Egbert only had time to unhitch his horse and let the burning vehicle go.

Mr. Egbert, in company with Professor Edward Kelley, of Wellington, were on their way from the home of the former to attend the Woodmen's picnic at Langdon Saturday. During the trip, by some means unknown, a fire started under the seat, and for some distance the travelers left a trail of smoke behind them, while they proceeded on their way all unconscious of the blaze.

A neighbor attempted to tell them the buggy was on fire, but Mr. Egbert failed to hear, and drove on. When they neared the picnic grounds another neighbor stopped them, with the same story. This time he was understood, and Mr. Egbert lifted the flap at the back of the vehicle, to be met with a sudden burst of flame, and in a moment everything in the vicinity of the seat was afire.

Without ceremony, Mr. Egbert franticly unhitched the hose while the picnic crowd gathered around, and a moment later about all there was left of the vehicle was the frame.

The cause of the fire remains a mystery. Mr. Egbert has a theory, but the only thing of whixh he is sure is that his buggy was on fire when discovered, and that subsequently the body and seat burned up. He believes a match must have been dropped under the cushion, and that during the drive it was struck and set fire to the excelsior. The fire smouldered for some time, and when given air when Mr. Egbert lifted the flap at the back of the buggy, suddenly burst into flame.

Typed envelopes will reach addresses one day earlier than those handwritten. Use Capital Letters, no Punctuation, and the Nine Digit Zip Code. If you are using a colored envelope, type the name, address and zip code on a white label and apply this to the envelope.

Postal machine scanners read envelopes from the bottom up, starting with the zip code. If anything is typed lower than the zip code, the letter will be held until it can be manually sorted. Mail will reach its destination at least a day sooner if you use zip codes, and using the additional 4-digit number is even better.

Self-addressed stamped envelopes (SASE) folded inside a letter is a <u>violation of postal regulations</u> because they jam postal sorting machines. This may cause the letter to be sent to the "dead letter" section. It is recommended you use a No. 9 envelope, which will fit inside the regular No. 10 business envelope without folding.

The post office sells a "message reply" double postal card for forty cents. If you're requesting a brief reply this is the most economical way to go.

OBITUARIES CAN BE INFORMATIVE

OBITUARY

Frederick William Hoffman was born October 5, 1847, in Niederhofen by Niewied on the Rhine, Germany. He died in his home near Preston, Kansas, June 17, 1928.

In the fourteenth year of his age, he came to the United States and located in Pennsylvania. It was in Pennsylvania, at Jackson, in Columbia county, that he was married to Caroline Wagner on April 27, 1872.

To the union of William Hoffman and Caroline Wagner eleven children were born. Two of the children died as infants. One son, Charlie died when twenty-one years old. The aged mother and eight of the children are living. Those children are Mrs. Ella Truitt of Langdon; Ira Hoffman of Turon; Mrs. Emma Deffenbaugh of Willow Springs, Mo; Mrs. Lillie Trinkle of Preston, and Clarence, Oliver and Ed Hoffman also of Preston and William Hoffman of Cullison, Kan. Forty-one grand-children and four great grandchildren are living.

In 1877, Mr. Hoffman brought his family to Kansas and settled near the town of Larned. Ten years later they moved to Langdon, and in 1900 again moved, this time into Pratt county, locating near Preston. In the home just south of Preston he lived for the last twenty-eight years. It was there that he died.

With the spirit of the pioneer, Neighbor Hoffman and his faithful wife endured the hardships of a new land uncomplainingly. They had their part in the "Winning of The West."

Comrade Hoffman during the Civil War was a member of Company H, of the 79th Pennsylvania Infantry. He was the last member of The Old Army to leave Preston Community.

Services were conducted on Tuesday afternoon June 19, 1928, at the family home. The sermon was preached by Howard L. Williams, Methodist pastor at Preston, Brother L. E. Marvin, pastor of the Baptist Church at Preston, assisted in the service. Music was by a mixed quartet of Preston friends and by two young ladies, the Misses Anna Petrowsky and Stella Studer, who sang in the Tongue of the Fatherland. Burial was in the cemetery at Langdon.

Comrade Hoffman has entered The Low Green Tent, whose curtain never outward swings. Taps have sounded — Lights are out — The Soldier sleeps.

What can your find out about the family by reading this obituary? I have made a timeline of the information that I found in the obituary and some comments about other information that could be found in other sources

1847—William Hoffman was born October 5, 1847. In Niederhofen by Niewied on the Rhine, Germany. (There may be many places named Niederhofen in Germany. The addition of "by Niewied on the Rhine" narrows the search for the location of his birth.)

1861 — When he was fourteen years of age he emigrated to the USA and located in Pennsylvania. (Did he come alone or did he come with his parents and siblings? What immigration records are available?)

1872 — He married Caroline Wagner on April 27, 1872 in Jackson, Columbia county, PA. (Check the 1870 census for his parents and other Hoffman family members. Was Caroline listed as a member of a family in 1870? Check the county records for their marriage.)

1877 — The family of William and Caroline Hoffman moved to Larned, Kansas. (Check the land records for Pawnee county, Kansas for their place of residence. There could have been children born in Pennsylvania before they came to Kansas. Check the 1880 Pawnee county, Kansas census for the family. Did other Hoffman or Wagner families come to Kansas at the same time? What school did the children attend? What were the children's names? Are there any records of deaths in Pawnee county during 1877 and 1900? Look at marriage records for any of the children in Pawnee county)

1887 — William Hoffman moved his family to Langdon, Reno county, Kansas. (Are any of the children buried in the Langdon cemetery? Are their marriages for any of the children in Reno county? Check the books, "Cemetery Records of Reno County" and Early Marriage Records of Reno County 1872-1913" for more information. Do any land records give his place of residence?)

1900 — William Hoffman moved his family to near Preston, Pratt county, Kansas. (Check land records for the place of residence in Pratt county. Check school records for the names of the children still attending school. Some of the children may have married in Pratt county. Look for their marriages.)

1928 — William Hoffman died in the family home south of Preston, Pratt county, Kansas. He was buried in the cemetery in Langdon, Kansas. (Check the book "Cemetery Records of Reno County" for other family members buried in the Langdon cemetery.)

William's daughters married men with the surnames of Truitt (Langdon), Deffenbaugh (Willow Springs, Mo), Trinkle (Preston) as of 1928. His sons lived in Turon, Preston and Cullison, Kansas. William had 41 grandchildren and four great grandchildren at the time of his death. Check the 1920 census for their families.)

William served in the Civil War as a member of Company H, of the 79th Pennsylvania Infantry. (What war records are available for Company H? Did he get a pension? Did Caroline apply for a pension?)

Things I haven't mentioned are newspaper articles for this family. There should be probate records for William Hoffman. Obituaries for Charles Hoffman, Caroline Wagner Hoffman and possibly for the children who died as infants. Church records are another possibility, as two churches are listed in William's obituary.

To organize your thoughts when an obituary like William Hoffman's is found, take a family group sheet and start filling out the blank spaces with the information that you find. Under notes include church references, ages at time of death, places of residence and then make a timeline of the events that are given in the obituary.

I certainly find this obituary informative and I want to thank Karen Burgess for giving it to me. Karen copied this from the Turon Weekly Press, Thursday, June 28, 1928.




CELEBRATES 85TH BIRTHDAY


