## PAST PRESIDENT OF THE RENO COUNTY GENEALOGICAL SOCIETY DIES

Raymond Stewart, 94, died 29 Sep 2004 at The Cedars, McPherson.

Raymond, the son of Lloyd Allen and Sarah Ann McGee Stewart, was born the 25th of February 1910 in Saline county, Kansas. He graduated from Kansas State University in 1941 and received a master's degree in 1959. He was a vocational agriculture and social science teacher at Nickerson High School and Hutchinson Community College. In 1990, he moved from Hutchinson to McPherson.

He married Anna Genevieve Marker at Atchison, Kansas. She died the 18th of September 2000. He is survived by two sons, R. Dean, McPherson, and Evan R. Stewart, Leawood, five grandchildren; and four great-grandchildren; three brothers, James Arthur, Wichita, Boyd Harold, Eureka and Thomas Neal Stewart, Houston; a sister, Lizzielou Phillips, Arlington, TX. He was preceded in death by a brother, Harley Allen Stewart, and a sister, Hope Avis Baker.

Raymond was a long time member of the Reno County Genealogical Society and served as president of the society in 1983; past president of the Sons of the Plains Chapter of Sons of the American Revolution; past president of the Hutchinson Area Retired Teachers Association and a member of the McPherson Area Retired Teachers Association. He served in the U. S. Navy during World War II in the Pacific Theater of Operations. He belonged to the First United Methodist Church in McPherson.

The funeral was Saturday, October 2, 2004 at the First United Methodist Church, McPherson. Interment will be in the Ozawkie Cemetery, Jefferson County, Kansas.

During World War I there were three registrations. The first, on June 5, 1917, was for all men between the ages of 21 and 31 (b. 1886-1896). The second, on June 5, 1918, registered those who attained age 21 after June 5, 1917. (A supplemental registration was held on August 24, 1918, for those becoming 21 years old after June 5, 1918. This was included in the second registration.) (b. 1897) The third registration was held on September 12, 1918, for men age 18 through 45 (1873-1900).

## **REVOLUTIONARY WAR PENSIONS**

The dates of the three major pension laws which applied to the Revolutionary War veterans: 1776—temporary pensions for disabled 1818—pensions for those in need of financial assistance even if not disabled 1832—pensions for all veterans who had served more than 6 months

## Three types of pensions:

Disability pension: personal disability incurred in line of duty.

Service pension: for serving specified periods of time.

Del Ray, for anyone who is interested, is the present day Glasco, Kansas. Glasgow was shortened to Glasco by the postmaster, H. C. Snyder, when the name was sent in for the purpose of simplification.

## Thursday, June27, 1907

Another pretty wedding celebrated last evening was that of Miss Linda Valeria Schlaudt, daughter of Mr. and Mrs. H. Schlaudt and Mr. Hermann Spencer Bliss of Wichita. The marriage occurred at the bride's home, 404 East Third street, which was artistically decorated for the occasion. The hall and ceremony room was in smilax and marguerites and the stair case was twined with a rope of flowers. The bridal couple stood in front of the mantel which was banked with ferns and marguerites. In the living room roses and sweet peas were used and in the dining room marguerites with a basket of flowers as the table centerpiece.

Before the ceremony Miss Ola Meyer of Kansas City, a cousin of the bride sang "All For You," accompanied by Miss Esther St. John and at 3:30 o'clock Miss Edna Schlaudt played Mendelssohn's march for the entrance of the bridal couple preceded by Miss Hazel Stout who carried the ring in a lily. Rev. H. E. Wolfe of the First Methodist Episcopal church performed the ceremony using the ring service.

A three course lunch was served in the dining room and Mrs. Schlaudt was assisted by Miss Cornelia Ryker, Miss Ruth Randle, and Miss Edna Schlaudt.

Mrs. Bliss' toilette was of silk chiffon voile over taffeta, hand embroidered and trimmed with Baby Irish lace. The long tulle veil was fastened in the coiffure with orange blossoms and she carried bride's roses. The ring bearer wore a dainty white Swiss dress.

Mr. and Mrs. Bliss left last evening on Santa Fe train No. 8 for Kansas City and Escelsior Springs, and will be at home later in Wichita and after September will live in Chicago. Mrs. Bliss' traveling suit was of Copenhagen Blue and was worn with a hat of champagne colored straw.

The guests from out of town for the wedding were Mr. and Mrs. E. H. Bliss, Miss Julia Bliss, Mr. Lawrence Bliss of Winfield, Miss May Bliss of Kansas City, Mr. and Mrs. Jesse Hermann and son of Junction City and Miss Ola Meyer of Kansas City.

He began his teaching career in Wichita and in 1961 moved his family to Anaheim, California to help fulfill the enormous demand for teachers during the high-growth aerospace era in Orange County. He taught Spanish at Dale Junior High, Western High School and was both teacher and counselor at Cypress College. During this time, he also worked at the Anaheim Parks and Recreation department as the Director of the Teen Center. During the 1970', Ed worked for the State of California Chancellor's Office as a Director of Funding and Curriculum for the States community colleges. Later, Ed became the Dean of instruction at Laney College in Oakland from where her retired. However, Ed's passion for helping and mentoring others led him to Santa Ana College as Dean of vocational education where he established the minority programs to widen student education to those less fortunate.

Continuing his assistance to those in need, Ed became the director George Washington Community Center in Anaheim providing a long list of social services to families and seniors. During this time, he also organized the Greater Anaheim Soccer League which began with eight teams and grew to 58 under his leadership. His "second retirement" occurred in 1990, when he chose to devote his time to his grandson, Devin. In addition, he contributed his time and administrative experience to South Shores Church and Crown Valley Church.

Ed is survived by his wife Natalie, daughter Diane, son Edward Charles, grandson Devin, and sisters, Connie Kirkpatrick, and Lillian Torrez.

## INTERNET DEFINITIONS

## **Spyware**

Software that gathers and transmits information without one's knowledge. Spyware programs usually track information about the Web sites visited, browser and system information and your computer IP (Internet Provider) address (the number that represents a network device on the internet).

## **Adware**

Software that supports itself or another program by displaying ads while you are connected to the Internet. Most adware programs track how you browse the Internet and report the information to an interested party.

## Browser

Aggressive advertising software programs that change the settings of your browser without your knowledge. These can be very annoying and may appear as a virus at first (slow internet connection and lots of network activity). Typical changes from hijacking software are: The browser's home page address, search bars, tool bars, the creation of desktop shortcuts and intermittent advertising pop-ups. Once a browser is hijacked it may also redirect links to other sites that advertise or collect your usage information.

## **MEMORIES**

Type the family stories and the bits and pieces of info you remember. Do this for every family in the different lines being researched. Share them with siblings, mom and others. While they give you THEIR version of the event, take notes.

Share the documented info discovered. There is always at least a small grain of truth in everyone's version. Their views help to pick away at the mortar of a few brick walls. All the views are transcribed and added together. For those writing a family history, what a help!

## **PASSWORDS**

PASSWORDS FOR THOSE SENIOR MOMENTS Logging on those 'senior moments' by Ron Hughes from The Prospector, Vol. 24 No.2, April 2004, Page 6.

The January issue of *The Prospector* contained an article regarding the use of passwords and how important it is to maintain them in a safe man-

ner. The article pointed out that you should print a list of all your passwords in case your computer crashes or some other tragedy strikes. Reading the article reminded me of how tedious it was in the old days to record and update all my passwords (I use over 40). If you are like most of us, maintaining such information on 3x 5 cards is just too much work.

Well I have a solution. It's called RoboForm. By using this application software, you will no longer have to maintain all those logs and cards.

Here is how it works. After you load Robo-Form onto your computer, it becomes a part of your internet browser. If you go to a website that requires a password, RoboForm will pop-up and ask if you want the program to remember the password for you. Click 'yes', and you will no longer have to remember your user ID an/or password for that website.

The next ime you go to the site, RoboForm will again pop-up and ask if you want it to fill in the ID and/or password for you. Click "yes", and it is done.

Filling in forms is not limited to User ID and Password Information. It will remember your address, phone number, social security number, safe combinations, etc.

Going on a trip? Well, download all your passwords to your laptop and take it with you. No need to take all those 3x5 cards so you can log onto Ancestry.com from Aunt Mary's house on the other side of the country. As an alternative, tell RoboForm to print a list of all your passwords. Have difficulty making up a password? RoboForm can make one up for you.

Sounds like something you just can't do without doesn't it? Go to http://www.RoboForm.com and download a free version., It's just like the full version, except you can only record about 30 passwords. The full version is limitless.

## **Rexrode Ancestor Book Published**

A new book, Johann Zacharias Rexroth the Pioneer, (Dolphin Publications, eighty pages) has been published that tells the life story of the first Rexrode to come to America. The book was researched and written by William D. Rexroad of Hutchinson, Kansas, the 5g-grandson of Zach, as the author calls him. Rexroad spent four years on the book and made five trips to Virginia, West Virginia, and Pennsylvania to conduct research, take photographs, and interview residents.

Rexroad said this is the first publication that has told the complete story of Zach's life, from his 1725 birth in Germany to his 1799 death in Pendleton County, Virginia (now West Virginia). Bits and pieces of his life story have been published previously but this is the first time it has all been put together under one cover. The book contains numerous photographs and maps that show where Zach lived. Some early American history is also included to give the reader a feel for how life was lived during Zach's lifetime.

Considerable new information about Zach was discovered in the course of research for the book, Rexroad said, and some of it is at odds with popular belief. The book describes in detail when and how he came to America (not in 1736), who is wife was (not Catherine), where he lived (not on the South Branch), and other aspects of his life not previously published. Rexroad is concerned this could provoke controversy but assures readers that it is all based on solid research, the references for which are given in the book.



The plane was flying over a bleak, fozen country at the time Captain Kleinschmidt reported it falling and it may be weeks before the truth will be known of what has happened to the party.


There were four aboard, three men and one woman and a great deal of supplies and equipment.

## Article I: Name

The name of this organization shall be the Reno County Genealogical Society of Hutchinson, Kansas.

## Article II: Objectives

The objectives of this society shall be to:

- 1. Further a popular interest in genealogy by acquiring genealogical, historical and biographical information to share with its members.
- 2. Record and preserve genealogical records.
- 3. Add to the genealogical and historical knowledge of its members.
- 4. Assist members in the compilation of family histories.

## Article III: Policies

- Section 1. The Reno County Genealogical Society is organized as a corporation not for profit under the Corporation Laws of Kansas and by its charter is dedicated to conduct its business operation under the requirements of Internal Revenue Code section 501(c)(3) as a tax exempt organization.
- Section 2: The purpose of this society shall be mainly educational and shall be developed through guest speakers, workshops, committees and projects.
- Section 3. This society shall be non commercial, nonsectarian and nonpartisan. No commercial enterprise and no candidate shall be endorsed by it. Neither the name of the society nor the names of its officers in their official capacities shall be used in any connection with a commercial concern or with any partisan interest or for any purpose other than the regular work of the society.
- Section 4.. This society may cooperate with other organizations and agencies active in

genealogy and history provided they make no commitments which bind their member groups.

- Section 5. All genealogical, historical and biographical records acquired by the society shall remain the property of the society. Reproduction for personal gain of said records shall require the express written permission of the society.
- Section 6: Upon dissolution of the society, the board of directors shall, after paying or making provision for payment of all the liabilities of the society, dispose of all the assets of the society exclusively for the purposes of the society, in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) as the board of directors shall determine. Any such assets not disposed of shall be disposed of by the District Court of Reno County, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

## Article IV: Membership and Dues

- Section 1. Any person who is interested in the objectives for which this society has been formed may become a member upon payment of dues.
- Section 2. The annual membership dues for this society shall be set by the executive committee subject to approval of the membership. Dues shall include both spouses of a family. Dues are payable January 1 and become delinquent February 1st of the same year. A notice of dues will be inserted in the 4th quarterly of the year.
- Section 3. In the event of expenses incurred for special programs, speakers, workshops or projects; a special assessment may be levied or collection taken to cover said expenses.

## Article V: Fiscal year

Section 1: The fiscal year shall begin January 1 and end December 31.

## Article VI: Officers and their election.

- Section 1: The officers of this organization shall be a president, vice-president, treasurer, recording secretary and corresponding secretary. The officers shall be elected by ballot at the annual meeting; however, if there is but one candidate for any office, by motion from the floor, the election may be by voice. Officers shall serve for a term of one year and shall remain in office until their successors are elected.
- Section II: Nominations for officers shall be made by a nominating committee of at least three members, elected by the organization one month prior to the election of officers. The nominating committee shall report at the election meeting the name of at least one candidate for each office to be filled. The consent of each candidate must be obtained before his name is placed in nomination. Additional nominations may be made from the floor provided the consent of each candidate has been obtained before his name is place in nomination.
- Section III: Vacancies in the offices other than president shall be filled by appointment of the president, subject to the approval of the board of directors, to fill the unexpired term. In case of an unexpired term of president, the vice-president shall fill the unexpired term.
- Section IV: All officers and committee chairpersons upon retiring shall deliver to their successors all moneys, account records, books, papers and other properties of the society.

## Article VII: Duties of officers.

- Section I: The president shall preside at all meetings of the society and of the executive committee; shall be a member ex-officio of all committees except the nominating; and shall perform all other duties usually pertaining to the office.
- Section II: The vice-president shall act as aide to the president and shall perform the duties of the president on the absence of that officer.
- Section III: The recording secretary shall keep a correct record of all meetings of the society and of the executive committee.
- Section IV: The corresponding secretary shall conduct the correspondence of the society, send out notices of executive committee and other meetings and correspond with persons signing the guest register in the library.

Section V:

The treasurer shall keep an accurate account of receipts and expenditures of the society; and shall pay out funds only as authorized by the society. All monies of the society except for research checks shall be received by the treasurer and kept in a bank account. The research checks will first go to the research chairman. A statement of account shall be presented at every meeting of the society and at other times when requested by the executive committee. The treasurer's accounts shall be audited annually. An auditor or an auditing committee shall be appointed by the executive committee at least two weeks before the annual meeting.

## **Article VIII: Meetings**

Section I:

A regular meeting of this society shall be held on the third Monday of each month at 7:00 PM at the library, unless otherwise provided by the society or by the executive committee. Five days notice shall be given of change of meeting date. Special meetings may be called by the executive committee, five days notice having been given. At the executive board and general meetings in October, the nominating committee reports shall be received and officers elected in November.

Section II:

The privilege of holding office, making motions, debating and voting shall be limited to individual members of the society whose dues are current.

Section III:

One-fourth of the membership shall constitute a quorum.

Section IV:

Business transacted at a regular meeting of the organization will ordinarily follow the order here given.

- 1. Call to order
- 2. Reading and approval of minutes
- 3. Statement of treasurer
- 4. Reading of communications
- 5. Reports and their disposal
  - a. Executive committees
  - b. Standing committees
  - c. Special committees
- 6. Unfinished business
- 7. New business
- 8. Announcements
- 9. Program
- 10. Adjournment

## **Article IX: Executive Committees**

Section I:

The executive committee shall consist of the officers of the society and the chairmen of standing committees. The members of the executive committee shall serve until their successors are elected.

Section II:

The duties of the executive committee shall be

- a. to transact necessary business in the intervals between organization meetings and such other business as may be referred to it by the society;
- b. to approve the plans of work of the standing and special committees;
- c. to present a report at the regular meeting of the society;
- d. to appoint an auditor or an auditing committee at least two weeks before the annual meeting;
- e. to prepare and submit to the society for approval a budget for the fiscal year; and
- f. to approve routine bills within the limits of the budget.

Section III: Regular meeting of the executive committee shall be held monthly, the time to be fixed by the committee at its first meeting of the year. A majority shall constitute a quorum. Special meetings of the executive committee may be called by the president or by a majority of the members of the committee.

## **Article X: Standing Committees**

Section I:

Such standing committees shall be created by the executive committee as may be required to promote the objectives and interests of the society. The chairmen of the standing committees shall be selected by the officers of the society. Their term of office shall be one year.

Section II:

The chairmen of all standing committees shall present plans of work to the executive committee and no committee work shall be undertaken without the approval of the executive committee. When a Chairmanship becomes vacant, the executive board shall appoint a person to fill the unexpired term.

Section IV: Special committees may be appointed by the executive committee. A special committee is created for a specific purpose. When its work is done and its final report is accepted or adopted, it automatically goes out of existence.

## Article XI: Amendments

Section I: These bylaws may be amended at any general meeting of the society by a quorum of

the membership voting, provided notice of the proposed amendment has been given at the previous general meeting.

## Article XII: Rules of Order

Section I: The rules contained in Robert's Rules of Order, Revised shall govern this society in

all cases in which they are applicable and in which they are not inconsistent with

these bylaws.
